## ORDINANCE 2020-36

### ORDINANCE AUTHORIZING INCREASING ESTIMATED RESOURCES, SUPPLEMENTAL APPROPRIATIONS AND TRANSFER OF FUNDS OF THE CITY OF NORTHWOOD; AND DECLARING AN EMERGENCY.

WHEREAS, the Finance Director has determined the need to increase estimated resources, appropriate and transfer funds;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTHWOOD, OHIO:

**Section 1.** That the Finance Director is hereby authorized and directed to increase Estimated Resources in Fund 222 Streets Fund totaling \$125,000 as follows:
