## ORDINANCE 2015 - 29

### **AN ORDINANCE AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO A COMMUNITY REINVESTMENT AREA AGREEMENT WITH MCNERNEY DEVELOPMENT LLC AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City of Northwood has encouraged the development of real property and the acquisition of personal property located in the area designated as Community Reinvestment Area #3; and

**WHEREAS**, McNerney Development LLC is desirous of constructing a new industrial building at 6922 McNerney Road (hereinafter referred to as the "PROJECT") within the boundaries of Community Reinvestment Area #3, provided that the appropriate development incentives are available to support the economic viability of said PROJECT; and

**WHEREAS**, the Council of the MUNICIPALITY, by Resolution No. 2013-6, adopted on October 24, 2013 designated the area as a "Community Reinvestment Area" pursuant to Chapter 3735 of the Ohio Revised Code, and

**WHEREAS**, the Director of the Ohio Development Services Agency has determined on December 12, 2013 that the aforementioned area designated in said Resolution No. 2013-6 contains the characteristics set forth in Section 3735.66 of the Ohio Revised Code and confirmed said area as a Community Reinvestment Area under Chapter 3735, and

**WHEREAS**, the City of Northwood, having the appropriate authority for the stated type of project, is desirous of providing McNerney Development LLC, with incentives available for the development of the PROJECT in said Community Reinvestment Area under Chapter 3735 of the Ohio Revised Code, and

**WHEREAS**, the Property Owner has submitted a Community Reinvestment Area Application to the City and affected school boards pursuant to Chapter 3735.671 of the Ohio Revised Code, a copy of which is attached hereto, and

**WHEREAS**, the Property Owner has submitted a Community Reinvestment Area Agreement to the City pursuant to Chapter 3735.671 of the Ohio Revised Code, a copy of which is attached hereto.

### **NOW THEREFORE, BE IT ORDAINED BY THE CITY OF NORTHWOOD, WOOD COUNTY, OHIO, THAT**

**SECTION 1.** This Council hereby authorizes and directs the City Administrator, on behalf of the City, to execute the Community Reinvestment Area Agreement, as attached hereto as Exhibit 1, and to take such steps, and to provide such information and certifications, as are necessary and appropriate to carry out and implement the terms and conditions of said Community Reinvestment Area Agreement, and the requirements and policies of the Ohio Revised Code.

**SECTION 2.** It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the City of Northwood and the State of Ohio.






