Ordinance No. 2016-15 **ORDINANCE 2016-15** Passed May 26, 2016

ORDINANCE AUTHORIZING THE CITY OF NORTHWOOD TO PARTICIPATE IN THE DEPARTMENT OF TRANSPORTATION COOPERATIVE PURCHASING PROGRAM FOR THE YEAR 2016; AND DECLARING AN EMERGENCY.

WHEREAS, Section 5513.01 (B), provides for the opportunity for counties, townships, municipal corporation conservancy districts, park districts, created under Chapter 1545 of the Ohio Revised Code, port authorities, regional transit authorities, transit boards, state universities or colleges to participate in contracts of the Ohio Transportation for the purchase of machinery, materials, supplies or other articles.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTHWOOD, WOOD COUNTY, OHIO THAT:

SECTION 1: That the City Administrator requests authority in the name of the City of Northwood, as to participate in the Ohio Department of Transportation contracts for the purchase of machinery, materials, supplies or other articles which the department has entered into pursuant to Ohio Revised Code Section 5513.01 (B).

SECTION 2. That the City Administrator is hereby authorized to agree in the name of the City of Northwood to be bound by all terms and conditions as the Director of Transportation.

SECTION 3. The City Administrator is hereby authorized to agree in the name of the City of Northwood to directly pay vendors under each such contact of the Ohio Department of Transportation.

SECTION 4. That the City of Northwood agrees to hold the Director of Transportation, and the Ohio Department of Transportation harmless for any claim or dispute arising out of participation in a contract pursuant to Ohio Revised Code §121.22 of the Ohio Revised Code.


SECTION 5. It is found and determined that all formal actions of council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the City of Northwood and including §121.22 of the Ohio Revised Code.

SECTION 6. This ordinance shall take effect immediately after its passage as an emergency measure because timely execution of this Participation Agreement ensures Northwood's participation in cooperative purchasing of machinery, materials, supplies or other articles, benefits citizens of the City of Northwood and therefore is necessary to protect the health, safety and welfare of our citizens.




