ORDINANCE 2017-07

ORDINANCE AUTHORIZING INCREASING ESTIMATED RESOURCES AND THE TRANSFER OF FUNDS OF THE CITY OF NORTHWOOD; AND DECLARING AN EMERGENCY

WHEREAS, the Finance Director has determined the need to increase estimated resources, and make a transfer of funds that was included in the 2017 Budget;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTHWOOD, OHIO:

Section 1. That the Finance Director is hereby authorized and directed to increase Estimated Resources in Fund 230 Northwood Waste Fund (Brush Pickup Program) totaling \$ 25,000 as follows:

230-1400-41404 Transfer from General Fund \$ 25,000

Section 2. That the Finance Director is hereby authorized and directed to increase Estimated Resources in Fund 331 General Obligation Debt Fund totaling \$401,600 as follows:

331-1400-41404 Transfer from 401 C.I.P. Fund \$ 401,600

Section 3. That the Finance Director is hereby authorized and directed to increase Estimated Resources in Fund 705 Northwood Civic Events totaling \$3,000 as follows:

705-1400-41404 Transfer from General Fund \$ 3,000

Section 4. That the Finance Director is hereby authorized and directed to make the following transfer of funds:

FROM: 110-7610-57015	TO: 230-1400-41404	\$ 25,000
FROM: 401-8000-57015	TO: 331-1400-41404	401,600
FROM: 110-7435-57015	TO: 705-1400-41404	3,000

Section 5. It is found and determined that all formal actions of Council concerning or relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees, that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the City of Northwood and State of Ohio

Section 6. The effective date of this ordinance shall be the earliest date as allowed by law.
