ORDINANCE 2017-42

ORDINANCE AUTHORIZING INCREASING ESTIMATED RESOURCES OF THE CITY OF NORTHWOOD, AND DECLARING AN EMERGENCY

WHEREAS, the Finance Director has determined the need to increase estimated resources;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTHWOOD, OHIO:

Section 1. That the Finance Director is hereby authorized and directed to increase Estimated Resources in Fund 222 S.C.M.R Fund totaling \$111,300 as follows:

222-0400-40405	Gasoline Taxes	\$ 12,200
222-0400-40406	Auto Registration	9,300
222-0800-40801	Interest Income	89,800

Section 2. That the Finance Director is hereby authorized and directed to increase Estimated Resources in Fund 223 M.V.L.T. Fund totaling \$1,000 as follows:

Section 3. That the Finance Director is hereby authorized and directed to increase Estimated Resources in Fund 224 State Highway Fund totaling \$2,400 as follows:

Section 4. That the Finance Director is hereby authorized and directed to increase Estimated Resources in Fund 236 Special Law Enforcement Fund as follows:


Section 7. The effective date of this ordinance shall be upon signature by the Mayor.




