ORDINANCE 2019-31

ORDINANCE AUTHORIZING SUPPLEMENTAL APPROPRIATIONS OF THE CITY OF NORTHWOOD FOR FISCAL YEAR 2019, AND DECLARING AN EMERGENCY

WHEREAS, the Finance Director of the City of Northwood has reviewed October expenditures and finds the need to increase supplemental appropriations; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTHWOOD, OHIO:


Section 7. This ordinance shall take effect as an emergency measure in order to protect the health, safety and welfare of our citizens.


