(b) Ten (10) sets of all legal descriptions, originals, new and remaining. (c) Letter of intent, that includes consolidation information. The purpose for the split, proposed new buildings, businesses, and the names of all parties involved. (d) Fee - \$50.00	2. Application must be accompanied by the following: (a) Six (6) copies of site plan/survey (must be prepared by a certified engineer or surveyor) showing original dimensions of parcels/lots and parcel/lots to be consolidated. (b) Six (6) sets of all legal descriptions, originals, new and remaining. (c) Letter of intent, that includes consolidation information. The purpose for the split, proposed new buildings, businesses, and the names of all parties involved. (d) Fee - \$50.00
3. The deadline for submittal is a minimum of two (2) weeks prior to the regularly scheduled Planning Commission Meeting.	*Any fees incurred by the City of Northwood for City Engineer reviews will be forwarded to the property owner for 100% reimbursement.
